## ELECTION- WICASA – ICAI NAGPUR BRANCH

### **ELECTION RULES:-**

1. Eligibility To Vote:

Every Student who is an articled trainee Student as on 1st March 2025 and also continues to be an articled trainee on 18th March 2025 the date of election under the Nagpur Branch Jurisdiction shall be entitled to vote. The students are required to carry their identity cards issued by ICAI/Govt. of India to enable them to cast their votes. In case any student is yet to receive his/her Identity Card from ICAI, then he/she should carry certificate from employer under whom he/she is serving his/her Articleship specifying the date of commencement of Articleship.

2. Eligibility to contest:

Every student who fulfills the requirement as per Point No.1 above shall be eligible to contest for election to the Managing Committee of the WICASA Nagpur Branch provided his/her unexpired period of training is not less than 1 year as on election date.

3. Nomination:

Every nomination shall be in the prescribed form which can be obtained from the office of the Branch on any working day between 11.00 a.m. to 6.00 p.m. Nomination shall be forwarded to CA. Swaroopa Wazalwar, Returning Officer, C/o. ICAI Nagpur Branch (WIRC), 20/1, ICAI Bhawan, Dhantoli, Nagpur who has been appointed as "Returning Officer", by the Managing Committee of the ICAI Nagpur Branch (WIRC). Nomination shall reach her not later than 5.00 p.m. on 10<sup>th</sup> March 2025 along with the non-refundable nomination fee of Rs.25/- by cash. One student should not propose or second more than 6 candidates.

4. Polling:

In case of necessity, the Polling shall be held on 18th March 2025 at Seth Hargovind Agrawal Auditorium, Nagpur Branch Building, Nagpur between 10.00 a.m. to 5.00 pm. At the polling, every voter shall cast vote personally in favour of maximum 6 candidates only. Every candidate shall be entitled to depute one representative at the time of the polling by giving authority in the prescribed form.

5. Counting of Votes & Declaration of Result:

Immediately after the voting is over, the votes shall be counted and six persons getting maximum votes in the respective order shall be declared elected. In case of tie, the election among the concerned persons shall be by way of suitable mode of draw as may be decided by the Returning Officer. In case of any dispute, the objection shall be lodged with the Returning Officer after the counting is over. Her decision in such cases and in other procedural matters concerning the election shall be final and binding.
