Over the years it has been felt that the scope of our professional field is wide and can be further widened. With ever increasing scope of work, we, the professionals need to get geared up to attain the highest level of professionalism to serve our clients in the best possible manner. For that we need better infrastructure with wider spread of our existence.

The following chart illustrates the present scenario of practicing CA member/firms

The institute also appreciated that almost 94% of our practicing members are engaged in proprietary or very small partnership firms and therefore recognised the need for consolidation and unity amongst the small and medium sized firms to gain further strength. In order to have an orderly and sustainable growth of CA Firms, it was felt that the coming together of the firms begins with networking and then matures to mergers. Networking will enable the firms to develop working relationships with each other. Once the firms have developed sufficient confidence in each other then they can venture into a marriage which is the form of mergers. However, it is not to suggest that there cannot be mergers without networking.

The Institute to give boost to the capacity building of the Chartered Accountants firms, the Council in its 250th meeting held

in April 2005 had approved a scheme envisaging merger of two or more firms of Chartered Accountants into one firm so that larger firms could come into existence. In the Corporate world, merger and demerger have become universal practices for securing survival, growth, expansion and globalisation of enterprise and achieving multitude objectives. Merger is the fusion of two or more existing firms. To incorporate the spirit of Corporate World and to imbibe the consultation creed, probably the Council of ICAI used the term 'merger' and 'demerger' of C.A. Firms.

The mergers should be effected to develop core competencies and to render professional services of a larger range spread over bigger geographical area. A merged big entity will always be superior to a network arrangement. A network of such bigger entities will lead to formation of bigger firms in near future.

The guideline for merger of CA firms is self explanatory and hence neither reproduced nor discussed in detail in this write up.

The Council in its 280th meeting while considering issues relating to seniority of firm and name of the merged firm as a consequence to the merger of firms restated that as and when two or more firms of Chartered Accountants merge, the seniority of the oldest firm amongst the merging firms will be given to the merged firm and the merging firms will have flexibility to choose a name of the merged firm provided the provisions of the Regulation 190 are duly met and the seniority will be reflected as deemed seniority in the firm constitution certificate.

Attach chart prepared on the basis of Council Decision of 198th Meeting held from 25-27th February,1999 and 223rd Meeting held on 2 - 5th February 2002 by a study group on Capacity Building Measures of C.A. Firms as approved by Council illustrate how the date of seniority will be reckoned. (See Chart 1.1 enclosed on page no. 08)

The above new name can also be changed further with prior approval and subject to a few conditions prescribed by ICAI not discussed here.

DEMERGER

The advantage of a formal merger is the ability to demerge which will be formally recognised by the Institute. One of the impediments for the growth of the firms is that once a merger takes place there is no exit route. The merged entity loses its trade name and also its seniority forever. There is always a lurking feat that the premerger cordial relations may not continue after the merger. In the event of such fear coming true then the merging firm will be in a situation of having lost everything that it had before merger. Therefore, it is prescribed that the demerger can be demanded only within a period of 5 years from the date of merger. The clear rules of demerger will facilitate the merger i.e. in case of 75% or more of the continuing partners of one of the erstwhile merging firm have demerged after giving due notice to the other partners, then in such case, the merger shall come to an end and if the remaining erstwhile merging firms/ partners of the erstwhile merged firm decided to continue, then they should enter into a fresh Merger/Partnership Agreement. It is also provided that the Merger Agreement shall stipulate that in case 75% or more of the continuing partners of one of the erstwhile firms are willing to demerge, then they may do so after giving due notice to other partners & to the Institute. The demerged firm will be entitled to practice in its old trade name.

WHY MERGER FAILS

Combining firms merely to fill empty office space, spread technology costs or utilize excess staff may not be good enough reasons to proceed with a merger. Human emotion is an important component in merger decision, and a merger should feel like a win-win for both sides. Many people find change disconcerting as your firm's culture may not mesh with that of the other.







Following are some the reasons why mergerfails:

- ▶ Ego
- ▶ Impatience
- Unwillingness of partners to adapt to new changes
- Poorly thought out and communicated firm name
- ➤ The cultures of the new combined accounting practices
- Failing to have a succession plan, particularly for exiting partners in a timely manner, leads to inadequate capacity.
- A merger plan also must transition staff to their roles in the combined firm or face the risk of losing them.
- Failure to integrate technology can sink a merger
- Poor communication and transition planning

VERDICTS:

In case of ex-factory sales, transportation charges from place of removal to place of delivery is not includible in assessable value for payment of excise duty - CCE vs Ispat Industries Ltd - 2015 TIOL 40 SC CX.

CX-Co-appellant cannot be exonerated from penalty imposed u/r 26 of CER, 2002 even if the main appellant has paid the duty, interest and 25% of penalty in terms of proviso to Section 11A(2) of CEA, 1944 - Immunity is available to only those persons to whom the notice is issued u/s 11A(1) - Shri Ghanshyamdas Goyal Vs CCE-2015 TIOL-756 CESTAT

GST ROUND UP

The Constitution (One Hundred and Twenty-Second Amendment) Bill, 2014 (GST Bill) was moved for consideration in the Lower House on April 24 amid stiff resistance of the Opposition, which wanted the bill in respect of GST to be referred to a Standing Committee. Finance Minister Mr Arun Jaitley said the bill would be a "win-win" measure for all, and that the states had nothing to fear. Members of the Congress, led by its president Sonia Gandhi, along with MPs of the TMC, Left and NCP

staged a walkout after their plea for referring the Constitution Amendment Bill to the standing committee was not accepted. Though the AIADMK and BJD also opposed its consideration, they did not walk out.

Finance Minister is confident that once the Constitution Amendment Bill is approved, the next stage would be to get the approvals of various States and then get all the subordinate amendments drafted, circulated, accepted by all government and in the course of the year present before Parliament.

Chairman of Empowered Comittee hints at Revenue Neutral Rate of 27%.

Chairman confident of IT backbone to be ready by April 2016.

Next meeting of the panel would be held in Kerala on May 7 and 8. All Pending issues to be discussed at the meeting, including consideration of reports by various groups on Dual Control, Revenue Neutral Rates, Central GST (CGST), and Place of Supply Rules

Tamil Nadu voices protest against GST bill as it would result in huge revenue loss for manufacturing States due to destination principle. Tamil Nadu demands broad consensus on the critical issues should be evolved through the Empowered Committee before the enactment of the Bill is taken up. Tamil Nadu was opposed to the idea of according constitutional status to the GST Council as it would impact the autonomy of States in fiscal matters. It further demands petrol and petroleum products should be kept outside the purview of the GST in order to protect the fiscal capacity of the states. 100 per cent compensation should be provided to the States for the entire period of 5 years and States should be permitted to retain 4 per cent of the CGST (Central GST) portion of IGST (Integrated GST) on all inter-State sales/transfer of both goods and services.

Telangana Finance Minister Mr. Etela Rajender told the Central Government that it must pay compensation to States for the abolition of Central Sales Tax (CST) before going ahead with the Goods and Services Tax (GST).

Haryana has asked the Centre to make it mandatory for the Centre to compensate States for losses in the GST regime.

Insurance Scheme

Our honourable Prime Minister Mr. Narendra Modi launched three of his government's social security schemes on May 9, 2015 in Kolkata – Pradhan Mantri Jeevan Jyoti Bima Yojana (Life Insurance), Pradhan Mantri Suraksha Bima Yojana (Accidental Death & Disability Insurance) and Atal Pension Yojana (Pension Scheme).

These schemes are an extension to **Pradhan Mantri Jan-Dhan Yojana** (**PMJDY**) and would be covered under the government's **Jan Suraksha** initiative. These schemes are designed to be pro poor and promise to provide protection against the risks of dying too early (Pradhan Mantri Jeevan Jyoti Bima Yojana) or unable to work & earn due to partial or full disability (Pradhan Mantri Suraksha Bima Yojana) or living too long (Atal Pension Yojana).

These schemes are targeted to provide social security benefits to a large percentage of the low income earning population in India.

Highlights of Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) & Pradhan Mantri Suraksha Bima Yojana (PMSBY) (See enclosed Chart)

Features common to both these Schemes i.e PMJJBY and PMSBY-

Last Date for Enrolment – May 31, 2015 is the last date for getting enrolled for these schemes, but the government has given an extension of three months up to August 31, 2015 for us to get enrolled and give autodebit consent for these schemes. This enrolment period may be extended by the government for another period of three months, up to November 30, 2015. In case of PMJJBY one has to submit a self-certificate of good health in the prescribed proforma.

Toll-Free Numbers – 1800 110 001 / 1800 180 1111 – These two are the National Toll-Free Numbers for both these schemes.

Service Tax Exempt – Finance Minister Mr. Arun Jaitley has proposed to exempt this scheme from service tax. So, no service tax shall be charged on the premium payable.

Know Your Customer (KYC) – Aadhaar Card issued by the UIDAI will be the primary requirement for your KYC under these schemes.

Both these schemes are quite attractive and provide a combined cover of Rs. 4 lacs for an annual premium of just Rs. 342 (Rs. 300 + Rs. 12) to its subscribers, which works out to be less than Re. 1 a day.

In a country like India, where many members of a family are dependent on the primary earner's income to survive and grow, these schemes would play a very important role in providing a much required social security comfort to the citizens of India. The government is doing a wonderful job in taking these initiatives to attract low income group people to get themselves covered against the risks of untimely death or accidental disabilities. One should definitely subscribe to both these schemes.

Change the way you "GOOGLE"

Everybody knows how to "Google" but not everyone Googles efficiently. Majority of us probably use Google many times a day. But chances are, unless we are technology geeks, we probably still use Google in its simplest form.

This article shall focus on the advanced Google search tips. Compiled after effective research this article shall ensure that you do not pull your hair out in frustration in a desperate attempt to find something and rather you start using Google search like a pro.

The list is by no means comprehensive, but, it assures you that by learning and using the 12 search operators below, you'll rank up with the best of the Google experts out there

12 ADVANCED GOOGLE SEARCH TIPS 1. USE THE TABS

The very basic tip is to use the tabs, on top of every search are a number of tabs being: Web, Images, News and More. Using these tabs helps to define the kind of search one needs. Its primary and many people already make use of the tabs. However, if you are not using the tabs it is highly recommended to get associated with them.

2. USE QUOTES

When searching for something specific try using quotes to minimise guesswork for Google. When you put your search parameters in quotes the search engine searches for the phrase in the exact order you typed.

Example Search: If you want to search inbound marketing the engine will search for these words in any order. However if you search for "Inbound Marketing" it will search the phrase in the exact order and also locate specific information buried under other content if not sorted out correctly.

3. USE A HYPHEN TO EXCLUDE WORDS

Let's say you want to search for content about inbound marketing, but you want to exclude any results that contain the term advertising. To do this, simply use the "-" sign in front of the word you want to exclude. Example Search: inbound marketing -

4. USE A COLON TO SEARCH SPECIFIC SITES

If you are looking for content on a specific site, but can't seem to remember the URL, use the word 'site' followed by a colon to indicate which site you would like Google to search.

Example Search: Barack Obama site: cnn.com.

This will search for all of the content on Barak Obama that is available on CNN's website, removing results from other sites on Barak Obama.

5. USE THE ASTERISK

This is one of the most useful tools that Google has to offer. When you use an asterisk in a Google search, it will create a placeholder that will be filled in later on by the search engine.

Example Search: if you type deprecia* as your search term, your results will include depreciate, depreciating, depreciation, etc.

6. FIND SITES THAT ARE SIMILAR TO OTHER SITES

When there is a particular site that you like, such as amazon.com, for instance, and you want to find sites that are similar, there is a special trick for finding similar information.

Example Search: related: amazon.com When you search the link above, a number of different sites that are similar in content to Amazon will show up, leading you to great new sites to browse.

7. SIMILAR WORDS AND SYNONYMS

Let's say you want to include a word in your search, but also want to include results that contain similar words or synonyms. To do this, use the "~" in front of the word.

Example Search: "inbound marketing" ~professional

8. SPECIFIC DOCUMENT TYPES

If you're looking to find results that are of a specific type, you can use the modifier "file type:" For example, you might want to find only Power sPoint presentations related to inbound marketing.

Example Search: "inbound marketing" filetype:ppt

9. THIS OR THAT

By default, when you conduct a search, Google will include all the terms specified in the search. If you're looking for any one or more terms to match, then you can use the OR operator. (Note: The OR has to be capitalized).

Example Search: inbound marketing OR advertising

10. NUMERIC RANGES

This is a rarely used but highly useful tip. Let's say you want to find results that contain any of a range of numbers. You can do this by using the X..Y modifier (in case this is hard to read, what's between the X and Y are two periods). This type of search is useful for years (as shown below), prices, or anywhere where you want to provide a series of numbers.

Example Search: president 1940..1950

11. WORD DEFINITIONS

If you need to quickly look up the definition of a word or phrase, simply use the "define:" command.

Example Search: define:plethora

12. SEARCH FOR MULTIPLE WORDS AT ONCE

Google search is flexible. It knows you may not find what you want by searching only a single word or phrase. Thus, it lets you search for multiples. This can help narrow down your search to help you find exactly what you're looking for.

Example Search: "Best ways to prepare for a job interview" OR "How to prepare for a job interview"

Hope this list of advanced Google search tips proves useful for your future Google searches.

DIABETES



Diabetes has already become a huge epidemic of our times, and the number of diabetics will keep on increasing over the next 20 years or probably beyond that. A lot is being said and written about controlling diabetes and living a healthy life with diabetes, but the prevention aspect of diabetes also needs to be highlighted. - 3. Eat healthy: Eat a healthy diet that has low calories, especially low saturated fats. Trials have shown that fat intake should not exceed 30 percent of the total calorie intake, whereas saturated fats should be restricted

to just 10 percent. Include more of vegetables, fresh fruits, whole grains, dairy products and sources of omega 3 fats. Also, increase your fibre intake.

- 4. Eat smart by limiting your portion size: How much you eat and when you eat is as important as what you eat. Reducing portion size and dividing meals throughout the day reduces the risk of obesity and diabetes. Eating proportionately will definitely be more helpful than starving yourself and overeating later due to excessive hunger.
- 5. Be physically active: The best way to stay healthy is to exercise. It will not only help you to prevent diabetes but also have a positive effect on your overall health and well being. You will feel fresh and energetic.
- 6. Quit smoking: People who smoke double their chances of developing diabetes. Even if you follow other healthy habits but still continue to smoke, it's not going to help you. You have to kick your habit, only then other changes can have full positive impact on your health.
- 7. Limit your alcohol intake: Heavy drinkers are more prone to gain weight. With obesity your risk of diabetes increases.

If you're prediabetic, alcohol will cause a rise in blood sugar and you may soon become a diabetic.

- 8. Get sufficient sleep: A good night's sleep of at least 7-8 hours in a day is a must. Adequate sleep will keep your energy levels high during the day, and most importantly it will minimize your cravings for high-calorie
- 9. Manage stress: The more you will get stressed, the more you will tend to follow unhealthy habits. Studies show that stress hormones alter blood glucose levels directly and increase the risk of the diabetes. To lower your stress levels practice meditation, do yoga, listen to music or do any activity that makes you happy and stress free.
- 10. Regular health check up: There is no evidence that diabetes can be prevented indefinitely. Lifestyle changes can prevent it as long as you stay committed to follow them. Also, as you get older the risk of high blood pressure, heart diseases and other health problems increases, and these are all linked to diabetes in their own way. So, it's best to get a complete health check up done, particularly after the age of 45 years.

SCHEME II

Capital Investment Subsidy Scheme for construction/Expansion/ Modernization of Cold Storages/ Storage of Horticulture Produce

Eligibility: Cold Storages Projects including Controlled Atmosphere (CA) and their modernization are eligible for assistance under this component.

Pattern of Assistance: The assistance will be given as subsidy @ 35% of the capital cost of project in general areas and 50% in case of NE, Hilly & Scheduled Areas for a storage capacity above 5000 MT up to 10000 MT.

Note: The cost of project has been linked to capacity of the cold storage. The normative cost of different type of cold storages with different capacities has been prescribed by NHB

Lets take a brief glance at the standard cost prescribed by NHB

Description - Cold storage units Type 1
 - basic mezzanine structure with large chamber (of > 250 MT) type with single temperature zone

Standard Cost -

- @ Rs. 8000/ MT for capacity upto 5000 MT
- @ Rs. 7600/ MT for capacity between 5001 to 6500 MT
- @ Rs. 7200/MT for capacity between 6501 to 8000 MT
- @ Rs. 6800/MT for capacity between 8001 to 10000 MT
- 2. Description Cold storage units Type 2 Pre Engineering Building (PEB)Type for multiple temperature and product use, more than 6 chambers of < 250 MT) and basic material handling equipment.

Standard Cost -

- @ Rs. 10000/ MT for capacity upto 5000 MT
- @ Rs. 9500/ MT for capacity between 5001 to 6500 MT
- @ Rs. 9000/MT for capacity between

- 6501 to 8000 MT
- @ Rs. 8500/MT for capacity between 8001 to 10000 MT
- Description Cold Storage Units Typewith add on technology for Controlled Atmosphere

Standard Cost - Additional Rs. 10,000/MT for add on components of controlled atmosphere technology as per component wise cost

 Description - Technology induction and modernization of cold-chain

Standard Cost -

@ Rs. 5000/MT, for capacity between 5001 to 10000 MT

Components of modernization includes PLC equipment, packaging lines, dock levelers, advanced graders, alternate technologies, stacking system, modernization of insulation and refrigeration etc.

Note: For the purpose of calculation of capacity 3.4 cubic meters (cum.) (120 cubic feet (cft.) of chamber volume shall be considered equivalent to 1 MT storage capacity. To ensure, compliance of notified standards, all projects will be subjected to technical scrutiny by NHB empanelled Technical Appraisal Agency

SCHEME III

Technology Development and Transfer for Promotion of Horticulture. This scheme covers following components:

3.1 Description - Setting up of block / mother plant and root stock nursery(Area above 4 ha)

Assistance - 100% @ 100 Lakhs/ha

3.2 Description - Acquisition of technologies including import of planting material from other countries for evaluation and mass multiplication in order to increase production & productivity of horticulture crops

Assistance - Rs 50 Laks/Project

3.3 Description - Import/procurement of machines and Tools for horticulture for demonstration Purpose

Assistance - Rs. 50.00 lakh/ machine. 100% of total cost

3.4 Description - Development & Transfer of Technology

Assistance - Rs. 25.00 lakh/ project as 100% of total cost

3.5 Description - Product Promotion and Market Development Services- Horti-fairs Assistance - Rs. 2000.00 lakh Project Based

3.6 Description - Product Promotion and Market Development Services- Horti-fairs

Assistance - Rs. 25.00 lakh 100% of cost

3.7 Description - Exposure visit of farmers (Outside State)

Assistance - 100% of cost Project Based

3.8 Description - Visit Abroad for Government Officers

Assistance - Rs. 6.00 lakh per participant 100% of air/rail travel and course fee

3.9 Description - Organization/ Participation in Seminar /Symposia / Workshop for development of Horticulture

Assistance - Rs.10.00 lakh for International event (3-5 days)

- Rs. 5.00 Lakh for National event
- -Rs.3.00 lakh for Stale Level event
- Rs.0.50 lakh for District Level Event

3.10 Description - Accreditation and Rating of Fruit Plant Nurseries

Assistance - Rs. 1.00 lakh / nursery

Note: Scheme 3.1 to 3.4 can be claimed only through Govt. agencies or Public Sectors

SCHEME-IV

Market Information Scheme for Horticulture Crops -In order to increase the coverage of NHB from existing 36 markets of fruits & vegetable to 50 markets it has proposed this scheme. This would be done by outsourcing existing marketing / professional agencies/ unemployed Agriculture graduates or recognized/ established brokers in Mandi etc. Broadly the components of scheme include







generation of information on price, production, trends in various markets & develop nationwide communication network for farmers, different stakeholders and beneficiaries.

Assistance : Assistance shall be project based to actual cost and fixed monthly remuneration

SCHEME-V

Horticulture Promotion Services/ expert services and strengthening capability of NHB

This scheme shall include conduction specialized studies and surveys and to

carryout study / survey reports for use by targeted beneficiaries. In addition, technical laboratories shall be set up or cause to be set up and also provide technical services including advisory and consultancy services. This shall be done by NHB with or without services of outsourced experts.

Public notice will be issued calling offers from consultant / consultancy firms for empanelment. Consultants / Consultancy firms shall apply for getting empanelled.

A panel of consultancy firms / consultants would be finalized by Empowered Committee of the Board.

Assistance: 100% cost of the study shall be borne by the Board

The above mentioned schemes have come to operation from 1st April 2014 and it is expected that these scheme will contribute in increasing the productivity and to bring reforms in the sector. It shall also encourage & motivate farmers, entrepreneurs & self help groups to bring revolution in HORTICULTURE sector and to contribute to exports of the country.


